ROAD TRAFFIC

The A21 Trunk Road (John's Cross – Baldslow, Carriageways) (Temporary Prohibition of Traffic) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A21 Trunk Road, is satisfied that traffic should be prohibited on a length of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**), hereby makes the following Order:-

1. This Order may be cited as the A21 Trunk Road (John's Cross – Baldslow, Carriageways) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 26th February 2011.

2. In this Order:

"the trunk road" means the A21 Trunk Road near Hastings in the County of East Sussex;

"the length of trunk road" means both carriageways of the trunk road from John's Cross roundabout (A2100 London Road) to its junction with the A2100 (Junction Road) at Baldslow;

"works" mean slope reconstruction, tree removal, gully cleaning, bridge works, manhole surveys and associated works on the trunk road; and

"a works period" means a period of 9 hours starting at 2000 hours on Monday 28th February 2011 or on any subsequent day until 25th August 2012.

3. Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the length of trunk road.

4. The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (d) any vehicle being used for winter maintenance purposes; or

(e) a vehicle proceeding in the length of trunk road to or from premises accessible from, and only from, that length of road, to such extent as shall be indicated by traffic signs.

5. The A21 Trunk Road (John's Cross – Baldslow, Carriageways) (Temporary Prohibition of Traffic) (No.2) Order 2010(**a**) is hereby revoked.
