# The A36 Trunk Road (Wilton to Salisbury) (50 mph Speed Limit) Order 2006 (Variation) Order 2011

The Secretary of State for Transport, in exercise of powers conferred by section 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a), makes the following Order:-

- **1.** This Order may be cited as the A36 Trunk Road (Wilton to Salisbury) (50 mph Speed Limit) Order 2006 (Variation) Order 2011 and shall come into force on 18th February 2011.
- **2.** The A36 Trunk Road (Wilton to Salisbury) (50 mph Speed Limit) Order 2006 (**b**) is varied as shown in the Schedule attached to this Order.

### **SCHEDULE**

## **EXPLANATORY NOTE**

(This does not form part of the Order)

The A36 trunk Road eastwards from Wilton Roundabout is subject to a 30 mph speed limit for just over 100 metres then is subject to a 50 mph speed limit to Skew Bridge.

An analysis of recorded road traffic accidents on the A36 between Wilton Roundabout, Wilton and St Paul's Roundabout, Salisbury indicated a significant number of accidents involved cyclists and motorcyclists. In addition, the section of the A36 through Wilton is widely used by pedestrians.

In order to improve road safety on this section of the A36 it is proposed to reduce the length of the 50 mph speed limit at the western termination point and to introduce a 40 mph speed limit from the eastern end of the 30 mph speed limit eastwards for distance of approximately 743 metres, to include the approaches to the traffic signals at the junction with Netherhampton Road, known as Park Wall Junction.
