ROAD TRAFFIC

The A45 Trunk Road (Great Billing Way Interchange, Northampton) (Temporary Restriction and Prohibition of Traffic) Order 2011

 Made
 11th February 2011

 Coming into force
 18th February 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45") and connecting roads, is satisfied that traffic on four of those connecting roads in the County of Northamptonshire should be restricted or prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A45 Trunk Road (Great Billing Way Interchange, Northampton) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 18th February 2011.

2. In this Order –

"the roundabout" means the circulatory carriageway of the A45 at its

roundabout junction with the A5076 Great Billing Way and Crow Lane, known as Great Billing Way Interchange.

"the works period" means the period starting at 18:30 hours on Monday 21st

February 2011 and ending when the said works have been

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour in -
 - (a) the slip road leading from the eastbound carriageway of the A45 to the roundabout;

- (b) the slip road leading from the westbound carriageway of the A45 to the roundabout;
- (c) the slip road leading to the eastbound carriageway of the A45 from the roundabout, for a distance of 100 metres; and
- (d) the slip road leading to the westbound carriageway of the A45 from the roundabout, for distance of 100 metres.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in
 - (a) the slip road leading to the westbound carriageway of the A45 from the roundabout; and
 - (b) the slip road leading from the eastbound carriageway of the A45 to the roundabout.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of articles 3 and 4 shall not apply to any vehicle
 - (a) being used for police, fire brigade or ambulance purposes; or
 - (b) proceeding at the direction of, or with the permission of, a police constable;

and nothing in article 4 shall apply to any vehicle being used for or in connection with the said works.
