ROAD TRAFFIC

The A417 Trunk Road (Air Balloon Roundabout to Brockworth, Crickley Hill, Gloucestershire) (Temporary Prohibition of Traffic) Order 2011

Made - - - - 23rd February 2011

Coming into force - - 2nd March 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A417 Trunk Road ("the A417"), is satisfied that traffic on a length of that road in the District of Tewkesbury in the County of Gloucestershire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A417 Trunk Road (Air Balloon Roundabout to Brockworth, Crickley Hill, Gloucestershire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 2nd March 2011.

2. In this Order -

"the A417" means the A417 northbound from the northern edge of the Air Balloon Roundabout to a point 750 metres south of the Brockworth Overbridge;

"layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the trunk road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the works" mean highway maintenance works;

"a works period" means a period of 10 hours starting at 20.00 hours on Friday 4th March 2011 or any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5, no person shall, during a works period:
 - (a) cause or permit any vehicle to enter or proceed in the A417;

- (b) cause or permit any vehicle to enter, proceed or remain in the layby adjacent to the A417 northbound situated 880 metres north of the Air Balloon Roundabout:
- (c) cause or permit any vehicle on entering the A417 from Cold Slad Lane or Grove Farm (1000 metres west of Air Balloon Roundabout) to proceed in any direction other than leftwards.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;
 - (b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform:
 - (c) a vehicle being used in connection with the said works.
- **5.** The provisions of article 3(a) shall not apply to a vehicle proceeding to and from premises that are accessible from and only from the A417.
