2011**

Made - - - - *28th February 2011*

Coming into force - - *31st March 2011*

The Secretary of State for Health makes the following Order in exercise of the powers conferred by section 272(7) and (8) of, and paragraph 1(1) of Schedule 5 to, the National Health Service Act 2006(a).

The Treasury has consented to the making of this Order as required by paragraph 1(7) of that Schedule.

Citation and commencement

1. This Order may be cited as the National Health Service Trusts (Originating Capital) Order 2011 and shall come into force on 31st March 2011.

Originating capital of NHS trusts

2. The originating capital of an NHS trust specified in column 1 of the Schedule shall be the amount specified in the corresponding entry in column 2 of the Schedule.
