#### **Citation and commencement**

**1.** This Order may be cited as the National Health Service Trusts (Originating Capital) Order 2011 and shall come into force on 31st March 2011.

#### **Originating capital of NHS trusts**

**2.** The originating capital of an NHS trust specified in column 1 of the Schedule shall be the amount specified in the corresponding entry in column 2 of the Schedule.
