# The A45 Trunk Road (M42 Junction 6 to East of Stonebridge Roundabout) (60 Miles Per Hour Speed Limit) Order 2012 

Made - - - - 22nd March 2012<br>Coming into force - -<br>5th April 2012

The Secretary of State for Transport, in exercise of the powers conferred by section 84(1)(a) and (2), and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and of all other powers enabling her in that behalf, hereby makes the following Order:
1.This Order may be cited as the A45 Trunk Road (M42 Junction 6 to East of Stonebridge Roundabout) (60 Miles Per Hour Speed Limit) Order 2012 and shall come into force on 5th April 2012.
2. In this order -
"the first roundabout"
"the second roundabout"
"the first length of Trunk Road"
"the second length of Trunk Road"
means the circulatory carriageway at the roundabout junction of the A45 and the slip roads leading to and from the M42 motorway at Junction 6;
means the circulatory carriageway at the roundabout junction of the A45 and the A452, known as Stonebridge Roundabout;
means a length of the eastbound carriageway of the A45 from a point 467 metres east of the centre point of the first roundabout to a point 790 metres east of the centre point of the second roundabout;
means a length of the westbound carriageway of the A45 from a point 592 metres east of the centre point of the second roundabout to a point 455 metres east of the centre point of the first roundabout;

[^0]"a slip road" means -
(i) the slip road leading to the eastbound carriageway of the A45 from the first roundabout;
(ii) the slip road leading from the westbound carriageway of the A45 to the first roundabout;
(iii) the slip road leading from the eastbound carriageway of the A45 to the second roundabout, and (iv) the slip road leading to the westbound carriageway of the A45 from the second roundabout.
3. No person shall cause or permit any vehicle to be driven at a speed exceeding 60 miles per hour on the first roundabout, the second roundabout, the first length of Trunk Road, the second length of Trunk Road, or a slip road.
4. The 70 miles per hour, 60 miles per hour and 50 miles per hour (Temporary Speed Limit) Order 1977 as amended by The 70 miles per hour, 60 miles per hour and 50 miles per hour (Temporary Speed Limit) (Variation) Order 1978 are hereby amended by excluding any reference to the lengths of the A45 described in Article 3 of this Order.
