The A14 Trunk Road (Junction 23 Spittals Interchange, Cambridgeshire) (Temporary Prohibition of Traffic) Order 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A14 Trunk Road ("the A14") and connecting roads, is satisfied that traffic on lengths of that road and on one of those connecting roads in the County of Cambridgeshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order: -

1. This Order may be cited as the A14 Trunk Road (Junction 23 Spittals Interchange, Cambridgeshire) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 25th June 2012.

2. In this Order –

"Junction 23" means the A14/A141 Spittals Interchange;

"the roundabout" means the circulatory carriageway of the A14 roundabout at Junction 23;

"the trunk road" means -

- (a) the north bridge section of the roundabout, between the junctions of the westbound entry to, and the eastbound exit from, the A14, and
- (b) the south bridge section of the roundabout, between the junctions of the eastbound entry to, and the westbound exit from, the A14;

"the slip road" means the A14 westbound exit slip road at Junction 23;

"works" mean carriageway resurfacing to the north and south bridges at Spittals Interchange and routine maintenance to include barrier, drainage and verge maintenance, lighting repairs and signal works;

"a works period" means a period of 9¹/₂ hours starting at 20:00 hours on Monday 2nd July 2012 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the trunk road or the slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle –

- (a) being used for, or in connection with, the works or for traffic officer purposes,
- (b) being used for police, fire and rescue authority or ambulance purposes,
- (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform, or
- (d) requiring access to properties accessible from, and only from, the trunk road.
