ROAD TRAFFIC

The A5 and A483 Trunk Roads (Mile End Roundabout, Shropshire) (Temporary Prohibition of Traffic) Order 2012

Made - - - - 11th June 2012 Coming into force - - 18th June 2012

WHEREAS the Secretary of State for the Transport, being the traffic authority for the A5 Trunk Road ("the A5") and the A483 Trunk Road ("the A483"), is satisfied that traffic on lengths of those roads, near Oswestry in the County of Shropshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A5 and A483 Trunk Roads (Mile End Roundabout, Shropshire) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 18th June 2012.

2. In this Order:

"the roundabout"

means the circulatory carriageway at the roundabout junction of the A5, the A483 and the B4579 Shrewsbury Road, known as Mile End Roundabout;

"the trunk road"

means -

- (i) the northbound and southbound carriageways of the A5 from its junction with the roundabout to its roundabout junction with the A495 /B4580;
- (ii) the eastbound and westbound carriageways of the A5 from its junction with Shrewsbury Road at Aston Hall to its junction with the roundabout;
- (iii) the northbound and southbound carriageways of the A483 from its junction with Shrewsbury Road to its junction with the roundabout;

"the works period"

means the period starting at 20:00 hours on Monday 25th June 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the roundabout or the trunk road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - 5. The provisions of article 3 shall not apply to any vehicle-
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable;
 - (c) being used for or in connection with the said works; or
 - (d) proceeding in the trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
