ROAD TRAFFIC

The A11 Trunk Road (Waterhall Interchange, Newmarket, Suffolk) (Temporary Prohibition of Traffic) Order 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A11 Trunk Road ("the A11") and connecting roads, is satisfied that traffic on one of those connecting roads in the County of Suffolk should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A11 Trunk Road (Waterhall Interchange, Newmarket, Suffolk) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 30th July 2012.

2. In this Order –

"Waterhall Interchange" means, the A11/A14 (Junction 38)/A1304 Waterhall Interchange;

"tip of the nosing" means, as indicated by the road markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

"the link road" means the length of the A11 at Waterhall Interchange that links the A1304 Bury Road, Newmarket and the northbound carriageway of the A11 (known as Plantation Viaduct);

"works" mean removal of a temporary vehicle restraint system and parapet repair and replacement to Plantation Viaduct;

"a works period" means a period of 10 hours starting at 20.00 hours on Wednesday 1st August 2012 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5 no person shall, during a works period, cause or permit any vehicle to enter or proceed -

- (a) in the link road from its junction with the A1304 Bury Road, or
- (b through the gap, situated 80 metres northeast of its junction with the A1304 Bury Road, that links the southbound carriageway of the A11 with the link road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.

- 5. Nothing in article 3 shall apply to a vehicle
 - (a) being used in connection with the works or for traffic officer purposes,
 - (b) being used for police, fire and rescue authority or ambulance purposes,
 - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform, or
 - (d) requiring access to property which is accessible from, and only from, the link road.
