ROAD TRAFFIC

The A446 and A452 Trunk Roads (Temporary Restriction and Prohibition of Traffic) Order 2012

Made - - - - 11th July 2012

Coming into force - -18th July 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A446 Trunk Road ("the A446") and the A452 Trunk Road ("the A452") and connecting roads, is satisfied that traffic on lengths of those roads and on two of those connecting roads, in the County of Warwickshire and in the Metropolitan Borough of Solihull, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A446 and A452 Trunk Roads (Temporary Restriction and Prohibition of Traffic) Order 2012 and shall come into force on 18th July 2012.

2. In this Order:

"the first length of trunk road" means the northbound carriageway of the A452

from its roundabout junction with the slip roads leading to and from the A45 (Stonebridge Island) to a point 1.5 Kilometres northwest of

that roundabout;

"the second length of trunk road" means the northbound carriageway of the

A446 from its junction with the A452 Chester Road, to its roundabout junction with the slip roads

leading to and from the M6 at Junction 4;

"the third length of trunk road" the southbound carriageway of the A446 from its

roundabout junction with the slip roads leading to and from the M6 at Junction 4 to its junction

with the A452 Chester Road;

"a slip road"

means -

- i) the slip road leading to the northbound carriageway of the A446 from its roundabout junction with the A452 Chester Road, B4438 and Solihull Parkway;
- ii) the slip road leading from the southbound carriageway of the A446 to its roundabout junction with the A452 Chester Road, B4438 and Solihull Parkway

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002 (a) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period"

means the period starting at 20:00 hours on Wednesday 25th July 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road.
- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of trunk road, the third length of trunk road or a slip road.
- **5.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby adjacent to the second length trunk road;
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **7.** The provisions of:
 - (a) article 3 shall not apply to any vehicle being used for special forces purposes;
 - (b) articles 3, 4 and 5 shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable;

- (c) articles 4 and 5 shall not apply to any vehicle being used in connection with the said works; and
- (d) article 4 shall not apply to any vehicle proceeding in the trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
