ROAD TRAFFIC

The A38 Trunk Road (Barton-under-Needwood, Staffordshire) (Footway) (Temporary Prohibition of Traffic) (No.4) Order 2012

Made---6th August 2012Coming into force--13th August 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), is satisfied that traffic on a length of that road, at Barton-under-Needwood in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(**a**), and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A38 Trunk Road (Barton-under-Needwood, Staffordshire) (Footway) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 13th August 2012.

2. In this Order –

"the footway"	means the footway adjacent to the northbound carriageway of the A38 between its junction with Mill Lane and a point 300 metres north of that junction.
"bus stop area"	means any area of a carriageway on a side of the trunk road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025, 1025.1, 1025.3 or 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;
"the works period"	means the period starting at 09:00 hours on Monday 20th August 2012 and ending when the said works have been completed;

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any pedestrian to enter or proceed in the footway.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the bus stop area situated adjacent to the northbound carriageway of the A38 approximately 30 metres north of its junction with Mill Lane.

5. The provisions of article 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 6. The provisions of
 - (1) article 3 shall not apply to
 - (i) any pedestrian engaged in police, fire brigade or ambulance activities;
 - (ii) any pedestrian acting under the direction of, or with the permission of, a police constable; or
 - (iii) personnel engaged in the said works.
 - (2) article 4 shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes;
 - (ii) proceeding at the direction of, or with the permission of, a police constable; or
 - (iii) being used in connection with the said works.
