## **ROAD TRAFFIC**

## The A1 Trunk Road (Felton) (Temporary Restriction and Prohibition of Traffic) Order 2012

Made - - - - 9th August 2012

Coming into force - - 19th August 2012

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road, in the County of Northumberland, is satisfied that traffic on that trunk road should be restricted and prohibited because carriageway repair, lining and road stud renewal works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A1 Trunk Road (Felton) (Temporary Restriction and Prohibition of Traffic) Order 2012 and shall come into force on 19th August 2012.
- 2. In this Order; -

"the A1" means the A1 Trunk Road from the centreline of Helmespeth Junction northwards for a distance of 2030 metres;

"the southbound carriageway" means the A1 Trunk Road southbound carriageway from a point 290 metres north of the centreline of the C111 Felton North Junction southwards for a distance of 2050 metres;

"a layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the A1 Trunk Road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"footway" means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only;

"the works period" means a period of 10 hours starting at 20:00 hours on Monday 20th August 2012 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour or 40 miles per hour in the southbound carriageway.

- **4.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to be driven in the A1 at a speed exceeding:
  - (a) 10 miles per hour whilst traffic signs of a character authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on that road are displayed; or
  - (b) 40 miles per hour whilst such traffic signs in relation to that road are not displayed.
- **5.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to enter or wait in a layby situated adjacent to the A1 Trunk Road:
  - (i) northbound carriageway approximately 1000 metres north of Stannington Interchange underbridge;
  - (ii) northbound or southbound lanes approximately 500 metres north of Helmespeth Junction; or
  - (iii) southbound carriageway approximately 500 metres south of Felton North Junction or approximately 400 metres north of the C102 Guyzance Junction.
- **6.** Subject as mentioned in article 7 no person shall, during the works period, enter or proceed in the footway crossing points adjacent to the A1 Trunk Road approximately 1115 metres or 1530 metres north of Helmespeth Junction.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in articles 5 and 6 shall apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
  - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in articles 3 and 4 shall apply to any vehicle being used for a purpose specified in paragraph (a) of this article.

**8.** No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
