ROAD TRAFFIC

The A38 Trunk Road (Weeford to Branston, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38) and connecting roads, is satisfied that traffic on some of those connecting roads, between Weeford and Branston in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A38 Trunk Road (Weeford to Branston, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 27th January 2012.

2. In this Order:

"the works period"	means the period starting at 21.00 hours on Monday 30th
	January 2012 and ending when the said works have been
	completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed on -

- (a) the slip road leading to the northbound carriageway of the A38 from its roundabout junction with the M6 Toll, A5 and B5404 (Weeford Roundabout);
- (b) the slip road leading from the southbound carriageway of the A38 to Weeford Roundabout;

- (c) the slip road leading from the northbound carriageway of the A38 to the A5192 Cappers Lane;
- (d) the slip road leading from the southbound carriageway of the A38 to the A5127 Burton Road at Streethay;
- (e) any slip road leading to or from the northbound or southbound carriageway of the A38 at its junction with the B5016 (Barton Turn); and
- (f) any slip road leading to or from the northbound or southbound carriageway of the A38 at its roundabout junction with the A5121 and Branston Road at Branston.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 5. The provisions of article 3 shall not apply to any vehicle
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
