## ROAD TRAFFIC

## The A31 Trunk Road (Bere Regis Roundabout – Roundhouse Roundabout) (Temporary Prohibition of Traffic) Order 2012

*Made - - - - 28th August 2012* 

Coming into force - - 15th September 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A31 Trunk Road, is satisfied that traffic should be prohibited on a length of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A31 Trunk Road (Bere Regis Roundabout – Roundhouse Roundabout) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 15th September 2012.

## 2. In this Order:

"the trunk road" means the A31 Trunk Road in the County of Dorset;

"the length of trunk road" means both carriageways of the trunk road between Bere Regis roundabout (A35) and Roundhouse roundabout (A350);

"a side road" means any road leading to or from the length of trunk road between Bere Regis roundabout (A35) and Roundhouse roundabout (A350);

"works" means carriageway repairs, cable repairs and all associated works; and

"a works period" means a period of -

- (i) 7½ hours starting at 2200 hours on Monday 17th September 2012 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2230 hours on Friday 21st September 2012 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 22nd September 2012 or on any subsequent Saturday, or
- (iv) 7½ hours starting at 2230 hours on Sunday 23rd September 2012 or on any subsequent Sunday,

until 14th March 2014.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle
  - (a) to enter or proceed in the length of trunk road; or

- (b) to enter the length of trunk road from a side road or to enter a side road from the length of trunk road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
  - (a) a vehicle being used in connection with the said works;
  - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
  - (d) any vehicle being used for winter maintenance purposes; or
  - (e) a vehicle proceeding in the length of trunk road or a side road to or from premises accessible from, and only from, the length of trunk road to such extent as shall be indicated by traffic signs.
