ROAD TRAFFIC

The A5 Trunk Road (Preston to M54, Shropshire) (Temporary Prohibition of Traffic) Order 2012

Made - - - - 28th August 2012

Coming into force - - 4th September 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5 Trunk Road ("the A5"), is satisfied that traffic on a length of that road between Preston and the M54 motorway in the County of Shropshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A5 Trunk Road (Preston to M54, Shropshire) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 4th September 2012.

2. In this Order -

"the trunk road" means the eastbound carriageway of the A5 from its

roundabout junction with the A49 (Preston Roundabout)

to its junction with the M54 at Junction 7;

"layby" means an area of carriageway intended for the waiting of

vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a

suitable surface for the exercise of that right;

"the works period"

means the period starting at 21:00 hours on Monday 10th September 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.
- **4.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby adjacent to the trunk road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used for or in connection with the said works.
