ROAD TRAFFIC

The A556 Trunk Road (Southbound Carriageway between Bucklow Hill and the A50) (Temporary Prohibition of Traffic)
Order 2012

Made - - - - 2nd October 2012

Coming into force - - 21st October 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A556 Trunk Road is satisfied that traffic on a section of that trunk road in Cheshire East should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order:-

1. This Order may be cited as the A556 Trunk Road (Southbound Carriageway between Bucklow Hill and the A50) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 21st October 2012.

2. In this Order:

"the trunk road" means the A556 Trunk Road;

"works" means resurfacing work on the trunk road;

"the works period" means three nights between 2200 hours and 0500 hours (continuing to 0700 hours on Saturdays and Sundays) during a period starting on Monday 22 October 2012 and ending on Sunday 4 November 2012. However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

"the length of carriageway" means the southbound carriageway of the trunk road from the point where the centre point of the trunk road meets the junction with the A5034 Mereside Road/Chapel Lane to the point where the centre point of the trunk road meets the junction with the A50 Warrington Road.

- 3. Subject as mentioned in article 6 of this Order, during the works period, no person shall cause or permit any vehicle to enter or proceed in the length of carriageway.
- 4. Subject as mentioned in article 6 of this Order, during the works period, no person shall cause or permit any vehicle to make a left turn onto the trunk road from the A5034 Mereside Road.

- 5. Subject as mentioned in article 6 of this Order, during the works period, no person shall cause or permit any vehicle to make a right turn from Chapel Lane onto the trunk road.
- 6. The provisions of articles 3, 4 and 5 of this Order shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services, vehicles being used in connection with the works, or by traffic officers, or to any vehicle proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform.
