**The Welsh Language (Police Names) Order 2012**

The Secretary of State makes the following Order in exercise of the power conferred by section 25(1) of the Welsh Language Act 1993(a).

**Citation and commencement**

1. This Order may be cited as the Welsh Language (Police Names) Order 2012, and comes into force on 22nd November 2012.

**Welsh names**

2. There are hereby conferred on those police and crime commissioners established under section 1 of the Police Reform and Social Responsibility Act 2011(b) which are, by virtue of section 1(3) of that Act, known by the names listed in column 1 of Schedule 1 to this Order, the alternative names in Welsh specified in column 2 of that Schedule.

3. There are hereby conferred on those chief constables established under section 2 of the Police Reform and Social Responsibility Act 2011 which are, by virtue of paragraph 3 of Schedule 2 to that Act, known by the names listed in column 1 of Schedule 2 to this Order, the alternative names in Welsh specified in column 2 of that Schedule.
