ROAD TRAFFIC

The A47 Trunk Road (Soke Parkway, Nene Parkway Interchange Junction 15 to Paston Parkway Interchange Junction 20, City of Peterborough) (Temporary Prohibition of Traffic)

Order 2012

Made - - - - 22nd October 2012

Coming into force - - 29th October 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A47 Trunk Road ("the A47") and connecting roads, is satisfied that traffic on lengths of that road and on one of those connecting roads in the City of Peterborough should be prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A47 Trunk Road (Soke Parkway, Nene Parkway Interchange Junction 15 to Paston Parkway Interchange Junction 20, City of Peterborough) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 29th October 2012.

2. In this Order –

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

"the trunk road" means the A47 –

- (a) eastbound carriageway from the tip of the nosing of the exit slip road at the A1260 Nene Parkway Interchange Junction 15 to the tip of the nosing of the entry slip road at Bretton Gate Interchange Junction 16, and
- (b) westbound carriageway from its roundabout junction at the A15 Paston Parkway Interchange Junction 20 to the tip of the nosing of the entry slip road at Bretton Way Interchange Junction 17;

"the slip road" means the entry slip road to the westbound carriageway of the A47 from Fulbridge Interchange Junction 19;

"works" mean westbound carriageway repairs between Junction 20 and Junction 17 and inspection, survey and testing on Longthorpe Footbridge;

"a works period" means a period of 10 hours starting at 20.00 hours on Tuesday 6th November 2012 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the trunk road or the slip road,.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to any vehicle
 - (a) being used in connection with the works or for winter service maintenance or traffic officer purposes,
 - (b) being used for police, fire and rescue authority or ambulance purposes, or
 - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform.
