ROAD TRAFFIC

The A160 Trunk Road (Harbrough Roundabout to Eastfield Road) (Temporary Prohibition of Traffic) Order 2012

Made - - - - 31st October 2012

Coming into force - - 6th November 2012

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A160 Trunk Road, in the County of North Lincolnshire, is satisfied that traffic on that trunk road should be prohibited because carriageway resurfacing works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A160 Trunk Road (Harbrough Roundabout to Eastfield Road) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 6th November 2012.
 - 2. In this Order; -

"the A160" means the A160 Trunk Road;

"the eastbound carriageway" and "the westbound carriageway" mean, respectively, the A160 eastbound carriageway and westbound carriageway from its junction with Harbrough Road Roundabout to the centreline of its junction with Eastfield Road, a distance of 1100 metres;

"the central reservation" means that part of the A160 which separates its carriageways for the safety and guidance of traffic using that road;

"the roundabout" means the circulatory carriageway of Harbrough Road Roundabout;

"a layby" means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition "carriageway" means any way (other than a cycle track) comprised in the A160 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the works period" means a period of 10 hours starting at 20:00 hours on Wednesday 7th November 2012 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the eastbound carriageway, the westbound carriageway or the roundabout.

- **4.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to enter or proceed through the gaps in the central reservation opposite Town Street Junction north or Town Street Junction south.
- **5.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to enter or wait in a layby situated adjacent to the A160 eastbound carriageway approximately 370 metres west of Eastfield Road Junction.
- **6.** Subject as mentioned in article 7 no person shall, during the works period, cause or permit any vehicle to enter or leave the A160 eastbound carriageway or westbound carriageway at its junctions with Town Street.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission, of a constable or traffic officer in uniform.
