ROAD TRAFFIC

**The A30 Trunk Road & A38 Trunk Road (Various Laybys)
(Temporary Prohibition of Traffic) Order 2012**

Made - - - - *14th November 2012*

Coming into force - - *17th November 2012*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A30 Trunk Road (“the A30”) and the A38 Trunk Road (“the A38”), is satisfied that traffic on lengths of those roads between Exeter and Penzance and between Exeter and Bodmin in the County of Devon and in Cornwall should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A30 Trunk Road & A38 Trunk Road (Various Laybys) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 17th November 2012.

2. In this Order –

“layby” means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition “carriageway” means any way (other than a cycle track) comprised in the trunk road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

“the works” mean filter drain and other maintenance works;

“the works period” means the period starting at 08.00 hours on Monday 19th November 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter, proceed or remain in a layby adjacent to:

- (a) the eastbound and westbound carriageways of the A30 between its junction with the M5 Junction 31 Interchange at Exeter and its junction with the Eastern Green Roundabout at Penzance;

(b) S.I. 2002/3113; Part I

- (b) the eastbound and westbound carriageways of the A38 between its junction with the M5 Junction 31 Interchange at Exeter and its junction with Carminow Roundabout at Bodmin.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;
- (b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (c) a vehicle being used in connection with the said works.
