## ROAD TRAFFIC

The A12 Trunk Road (Junction 18 Sandon to Junction 20B Hatfield Peverel North, Essex) (Temporary Restriction and Prohibition of Traffic) Order 2012

*Made - - - - 6th February 2012* 

13th February 2012

Coming into force - -

WHEREAS the Secretary of State for Transport, being the traffic authority for the A12 Trunk Road ("the A12") and connecting roads, is satisfied that traffic on lengths of that road and on some of those connecting roads in the County of Essex should be restricted and prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A12 Trunk Road (Junction 18 Sandon to Junction 20B Hatfield Peverel North, Essex) (Temporary Restriction and Prohibition of Traffic) Order 2012 and shall come into force on 13th February 2012.

## 2. In this Order –

"Junction 18", "Junction 19", "Junction 20a" and "Junction 20b" mean, respectively, the A12/A414 Sandon Interchange Junction 18, the A12/A138/A130/B1137 Boreham Interchange Junction 19, the A12/B1137 Hatfield Peverel (South) Interchange Junction 20A, and the A12/B1137 Hatfield Peverel (North) Interchange Junction 20B;

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road:

"lay-by" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition "carriageway" means a way constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"a first length of trunk road" means the A12 -

(a) northbound carriageway from the centre point of the overbridge at Junction 18 to the tip of the nosing of the entry slip road at Junction 20B, and

(b) southbound carriageway from the tip of the nosing of the exit slip road at Junction 20B to the centre point of the overbridge at Junction 19;

"the second length of trunk road" means the northbound carriageway of the A12 from the tip of the nosing of the exit slip road at Junction 19 to the tip of the nosing of the entry slip road at Junction 20B;

- "a first slip road" means the A12 northbound –
- (a) entry slip road at Junction 18, and
- (b) exit slip road at Junction 19;
- "a second slip road" means the A12 northbound –
- (a) entry slip road at Junction 19, and
- (b) exit slip road at Junction 20A;

"the link road" means the length of A12 at Junction 19 which links the A138 and the northbound entry slip road, from its junction with the A138/B1137 (west) roundabout to its junction with the northbound entry slip road;

"works" mean carriageway resurfacing and the reinstatement of road markings and road studs;

"a works period" means a period of 9 hours starting at 21.00 hours on Monday 20th February 2012 or on any subsequent day until the works have been completed;

"the works period" means the period starting at 00.01 hours on Monday 20th February 2012 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6 no person shall cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on
  - (a) the first length of trunk road, during the works period, or
  - (b) a first slip road, a second slip road or the link road, during a works period.
- **4.** Subject as mentioned in articles 5 and 6 no person shall cause or permit any vehicle to enter or proceed in -
  - (a) the second length of trunk road, a second slip road or the link road, during a works period, or
  - (b) (i) any lay-by adjacent to the northbound carriageway of a first length of trunk road, or
    - (ii) the lay-by adjacent to the A12 southbound carriageway situated 200 metres south of the centre point of Station Road overbridge at Hatfield Peverel,

during the works period.

- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.
  - **6.** The provisions of article 4 shall not apply to a vehicle
    - (a) being used in connection with the works or for winter service maintenance or traffic officer purposes,
    - (b) being used for police, fire and rescue authority or ambulance purposes, or
    - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for a purpose specified in paragraph (b) of this article or to a vehicle falling within regulation 3(4) of the Road Traffic Exemptions
