**ROAD TRAFFIC**

**The A36 Trunk Road (Salisbury to Whaddon) (Temporary Prohibition of Traffic) Order 2012**

*Made* - - - - 4th January 2012

*Coming into force* - - 13th January 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A36 Trunk Road (“the A36”) and connecting roads, is satisfied that traffic on a length of that road and one of those connecting roads near Salisbury in Wiltshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:

1. This Order may be cited as the A36 Trunk Road (Salisbury to Whaddon) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 13th January 2012.

2. In this Order –

“the A36” means: (i) the A36 eastbound from the eastern edge of its roundabout junction with Bourne Way, Salisbury, to the tip of the nosing of the eastbound exit slip road at the Grinstead Road Junction, Whaddon; and (ii) the A36 westbound from the tip of the nosing of the westbound exit slip road at the Grinstead Road Junction, Whaddon, to the eastern edge of its roundabout junction with Bourne Way, Salisbury;

“the slip road” means the A36 westbound entry slip road at Whaddon;

“tip of the nosing” means the first point where an entry slip road joins the carriageway of a trunk road or the last point where an exit slip road leaves the carriageway of a trunk road;

“the works” mean carriageway resurfacing and toucan crossing works;

“a works period” means a period of 10 hours starting at 20.00 hours on Sunday 15th January 2012 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during a works period, cause or permit any vehicle to enter or proceed on the A36 and the slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;
- (b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (c) a vehicle being used in connection with the said works or for winter maintenance purposes;
- (d) a vehicle proceeding to or from premises that are accessible from and only from the A36.
