ROAD TRAFFIC

**The A453 and A52 Trunk Roads (Nottingham) (Temporary
Prohibition of Traffic) Order 2012**

Made - - - - 9th March 2012

Coming into force - - 16th March 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A453 Trunk Road (“the A453”), the A52 Trunk Road (“the A52”) and connecting roads, is satisfied that traffic on lengths of those roads and some of those connecting roads, in the City of Nottingham, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A453 and A52 Trunk Roads (Nottingham) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 16th March 2012.

2. In this Order:

“the trunk road”

means –

- (a) the southbound carriageway of the A52 from its junction with the slip road leading to the A453 Queens Drive Roundabout to its junction with the link road leading from that roundabout;
- (b) the northbound carriageway of the A52 from its junction with the A453 to its junction with the slip road leading from the A453 Queens Drive Roundabout; and
- (c) the northbound carriageway of the A453 from its junction with the slip road leading to the B679 Silverdale Roundabout to its junction with the A52.

“a slip road”

means the slip roads leading –

- (a) from the southbound carriageway of the A453 to Silverdale Roundabout;
- (b) to the northbound carriageway of the A453 from Silverdale Roundabout;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- (c) from the westbound carriageway of the A453 to Silverdale Roundabout; and
- (d) from the B679 Clifton Lane to the southbound carriageway of the A52;

“the link road” means the link road, which forms the flyover over Queens Drive Roundabout, leading from the northbound carriageway of the A52 Clifton Boulevard to the northbound carriageway of the A453 Queens Drive

“the works period” means the period starting at 21:00 hours on Monday 19th March 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road, a slip road or the link road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable; or
- (iii) being used in connection with the said works.
