ROAD TRAFFIC

The A38 Trunk Road (Weeford to Claymills) and the A5148 Trunk Road (Freeford, Lichfield) (Staffordshire) (Temporary Prohibition of Traffic) Order 2013

 Made
 26th March 2013

 Coming into force
 2nd April 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), the A5148 Trunk Road ("the A5148") and connecting roads, is satisfied that traffic on a length of the A5148 and some of those connecting roads, between Weeford and Claymills in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A38 Trunk Road (Weeford to Claymills) and the A5148 Trunk Road (Freeford, Lichfield) (Staffordshire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 2nd April 2013.

2. In this Order:

"the trunk road"

means the southbound carriageway of the A5148 from its junction with the A38 to its junction with the slip road leading from the roundabout junction of the A38 and A5206 at Freeford, south of Lichfield;

"a slip road"

means the slip road leading -

- (i) from the southbound carriageway of the A38 to the roundabout junction of the A5 and the slip roads leading to and from the M6 Toll (Junction T4) near Weeford;
- (ii) to the northbound carriageway of the A38 from the roundabout junction described in (i) above;
- (iii) from the southbound carriageway of the A38 to the roundabout junction of the A38 and A5206 at Freeford, south of Lichfield;
- (iv) from the northbound carriageway of the A38 to the A5192 Cappers Lane near Lichfield;
- (v) from the southbound carriageway of the A38 to the A5127 at Streethay;
- (vi) to and from the northbound carriageway of the A38 from and to Wood End Lane at Hilliards Cross;

- (vii) to and from the southbound carriageway of the A38 from and to the junction with Brookhay Lane and Wood End Lane at Hilliards Cross;
- (viii) from the northbound carriageway of the A38 to its roundabout junction with the A513 at Alrewas;
- (ix) from the southbound carriageway of the A38 to its roundabout junction with the A513 at Alrewas;
- (x) to and from the northbound carriageway of the A38 from and to the junction with Dogshead Lane near Efflinch;
- (xi) to and from the southbound carriageway of the A38 from and to Dogshead Lane near Efflinch;
- (xii) to and from the northbound carriageway of the A38 from and to the roundabout junction with the B5016 Station Road at Barton Turn;
- (xiii) to and from the southbound carriageway of the A38 from and to its roundabout junction with the B5016 and an unnamed road leading to Barton Business Park at Barton Turn;
- (xiv) to and from the northbound and southbound carriageways of the A38 from and to the roundabout junction with the A5121 and Branston Road at Branston;
- (xv) to and from the northbound and southbound carriageways of the A38 from and to the A5121 Derby Road at Claymills;

"the works period" means the period starting at 20:00 hours on Wednesday 3rd April 2013 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** The provisions of articles 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-
 - (i) being used for police, fire brigade or ambulance purposes;
 - (ii) proceeding at the direction of, or with the permission of, a police constable; or
 - (iii) being used in connection with the said works.
