ROAD TRAFFIC

The M621 Motorway (Junction 1 to Junction 7) (Temporary Prohibition of Traffic) Order 2013

 Made
 25th April 2013

 Coming into force
 3rd May 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the M621 Motorway and connecting roads, in the District of Leeds, in the County of West Yorkshire, is satisfied that traffic on some of those connecting roads, should be prohibited because cyclic maintenance and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the M621 Motorway (Junction 1 to Junction 7) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 3rd May 2013.
- 2. Subject as mentioned in article 3 of this Order, no person shall, during a period of 7 hours starting at 03:00 hours on Saturday 4th May 2013 or any subsequent Saturday or Sunday thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the M621 Motorway:
 - (i) clockwise or anti-clockwise exit or entry slip roads at Junction 1 (Beeston);
 - (ii) clockwise or anti-clockwise exit or entry slip roads at Junction 2 (Elland Road);
 - (iii) clockwise entry or anti-clockwise exit slip roads at Junction 2A (Cemetery Road Bridge);
 - (iv) clockwise or anti-clockwise exit or entry slip roads at Junction 3 (Holbeck);
 - (v) clockwise or anti-clockwise exit or entry slip roads at Junction 4 (Hunslet);
 - (vi) clockwise entry or anti-clockwise exit slip roads at Junction 5 (Tunstall);
 - (vii) clockwise exit or anti-clockwise entry slip roads at Junction 6 (Belle Isle); or
 - (viii) clockwise exit or anti-clockwise entry slip roads at Junction 7 (Stourton).
- **3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
