ROAD TRAFFIC

The M6 Toll Motorway (M6 Toll Junction T4 - M6 Junction 11a) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 3rd June 2013

Coming into force - - 10th June 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Toll Motorway ("the M6 Toll") and connecting roads, is satisfied that traffic on lengths of that motorway and some of those connecting roads in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order:-

1. This Order may be cited as the M6 Toll Motorway (M6 Toll Junction T4 – M6 Junction 11a) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 10th June 2013.

2. In this Order -

"the motorway"

means -

- i) the northbound carriageway of the M6 Toll from its junction with the exit slip road at Junction T4 to its junction with entry slip road at Junction T6;
- ii) the southbound carriageway of the M6 Toll from its junction with the exit slip road at Junction T6 to its junction with entry slip road at Junction T4;
- iii) the northbound carriageway of the M6 Toll from its junction with the exit slip road at Junction T6 to its merge point with the M6 at Junction 11a;

"a slip road"

means the slip road leading -

i) to the northbound carriageway of the M6 Toll at Junction T4;

- ii) to the northbound carriageway of the M6 Toll at Junction T5;
- iii) from the southbound carriageway of the M6 Toll at Junction T6;
- iv) to the southbound carriageway of the M6 Toll at Junction T6:
- v) to the northbound carriageway of the M6 Toll at Junction T6;
- vi) to the northbound carriageway of the M6 Toll from Norton Canes Motorway Service Area; and
- vii) from the southbound carriageway of the M6 Toll to Norton Canes Motorway Service Area;

"the works period"

means the period starting at 21.00 hours on Monday 17th June 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the motorway or a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform; or
 - (c) being used for or in connection with the said works or by a traffic officer in uniform.
