ROAD TRAFFIC

The A34 Trunk Road (M3 Junction 9 – Andover Road Interchange) (Temporary Prohibition of Traffic) Order 2013

 Made
 24th June 2013

 Coming into force
 20th July 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A34 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A34 Trunk Road (M3 Junction 9 – Andover Road Interchange) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 20th July 2013 and shall apply for a period of twelve months.

2. In this Order:

"the trunk road" means the A34 Trunk Road in the County of Hampshire;

"a link road" means -

- (i) the road leading from the northbound carriageway of the trunk road to the northbound carriageway of the A33 north of M3 Junction 9, or
- (ii) the road leading to the southbound carriageway of the trunk road from the southbound carriageway of the A33 north of M3 Junction 9;

"a slip road" means -

- (i) the road leading from the northbound carriageway of the trunk road to the southern roundabout at Three Maids Hill Interchange (A272/B3420),
- (ii) the road leading to the southbound carriageway of the trunk road from the northern roundabout at Three Maids Hill Interchange (A272/B3420),
- (iii) the road leading to the northbound carriageway of the trunk road from the southern roundabout at Three Maids Hill Interchange (A272/B3420),
- (iv) the road leading from the southbound carriageway of the trunk road to the northern roundabout at Three Maids Hill Interchange (A272/B3420),
- (v) the road leading from the northbound carriageway of the trunk road to the westbound carriageway of the A303 at Bullington Cross Interchange (A34/A30),
- (vi) the road leading from the northbound carriageway of the trunk road to the northern roundabout at Bullington Cross Interchange (A30/A303),

- (vii) the road leading to the southbound carriageway of the trunk road from the southern roundabout at Bullington Cross Interchange(A30/A303),
- (viii) the road leading to the northbound carriageway of the trunk road from the northern roundabout at Bullington Cross Interchange (A30/A303),
- (ix) the road leading from the southbound carriageway of the trunk road to the southern roundabout at Bullington Cross Interchange (A30/A303),
- (x) the road leading from the northbound carriageway of the trunk road at Tufton Interchange,
- (xi) the road leading to the southbound carriageway of the trunk road at Tufton Interchange,
- (xii) the road leading from the northbound carriageway of the trunk road at Litchfield Interchange,
- (xiii) the road leading to the southbound carriageway of the trunk road at Litchfield Interchange,
- (xiv) the road leading to the northbound carriageway of the trunk road at Litchfield Interchange,
- (xv) the road leading from the southbound carriageway of the trunk road at Litchfield Interchange,
- (xvi) the road leading from the northbound carriageway of the trunk road at Beacon Hill Interchange,
- (xvii) the road leading to the southbound carriageway of the trunk road at Beacon Hill Interchange,
- (xviii) the road leading from the northbound carriageway of the trunk road to the B4640 at Tot Hill Interchange,
- (xix) the road leading to the southbound carriageway of the trunk road from the B4640 at Tot Hill Interchange,
- (xx) the road leading to the northbound carriageway of the trunk road from the B4640 at Tot Hill Interchange,
- (xxi) the road leading from the southbound carriageway of the trunk road to the B4640 at Tot Hill Interchange,
- (xxii) the road leading from the northbound carriageway of the trunk road to the A343 at Andover Road Interchange,
- (xxiii) the road leading to the southbound carriageway of the trunk road from the A343 at Andover Road Interchange,
- (xxiv) the road leading to the northbound carriageway of the trunk road from the A343 at Andover Road Interchange, or
- (xxv) the road leading from the southbound carriageway of the trunk road to the A343 at Andover Road Interchange;

"works" mean essential carriageway repairs, signage and all associated works on the trunk road; and

"a works period" means a period of 8 hours starting at 2200 hours on Saturday 20th July 2013 or on any subsequent day until Saturday 19th July 2014.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a link road or a slip road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;

- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
