ROAD TRAFFIC

The A64 Trunk Road (Rillington) (Temporary Restriction and Prohibition of Traffic) Order 2013

Made - - - - 27th June 2013

Coming into force - - 7th July 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A64 Trunk Road, in the District of Ryedale, in the County of North Yorkshire, is satisfied that traffic on that trunk road should be restricted and prohibited because carriageway resurfacing, signing renewal and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A64 Trunk Road (Rillington) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 7th July 2013.
 - 2. In this Order; -

"the A64" means the A64 Trunk Road from a point 370 metres west of the centreline of its junction with Collinsons Lane eastwards for a distance of 1530 metres;

"the works period" means a period of 12 hours starting at 18:00 hours on Monday 8th July 2013 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven in the A64 at a speed exceeding:
 - (a) 10 miles per hour whilst traffic signs of a character authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on that road are displayed; or
 - (b) 40 miles per hour whilst such traffic signs in relation to that road are not displayed.
- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or leave the A64 Trunk Road at it's junction with:
 - (i) Sands Lane:
 - (ii) St Andrews Court;
 - (iii) Pine Tree Avenue; or
 - (iv) High Street (Rillington Crossroads).

- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle being used for a purpose specified in paragraph (a) of this article

and nothing in article 4 shall apply to any vehicle proceeding in the A64 to or from premises and property which is accessible for that vehicle from, and only from, that road.

6. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**a**) when used in accordance with regulation 3(5) of those Regulations.
