ROAD TRAFFIC

The M18 Motorway (Junction 2 to Junction 3) Temporary Prohibition of Traffic) Order 2013

Made - - - - 20th June 2013

Coming into force - - 7th July 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M18 Motorway, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on that motorway and some of those connecting roads should be prohibited because carriageway repair works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the M18 Motorway (Junction 2 to Junction 3) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 7th July 2013.
 - 2. In this Order; -

"the M18" means the M18 Motorway;

"the first length of carriageway" means the M18 northbound carriageway from the nose of the northbound exit slip road to the nose of the northbound entry slip road at Junction 2 (Wadworth), a distance of 1128 metres:

"the second length of carriageway" means the M18 northbound carriageway from the nose of the northbound exit slip roads at Junction 2 to the nose of the northbound entry slip road at Junction 3 (St. Catherine's), a distance of 4050 metres;

"the third length of carriageway" means the M18 northbound carriageway from the nose of the northbound exit slip road to the nose of the northbound entry slip road at Junction 3, a distance of 705 metres;

"a slip road" means any of the following M18 slip roads:

the northbound entry slip road at Junction 2;

- (ii) the northbound exit slip at Junction 2
- (iii) the northbound exit slip road at Junction 3; and
- (iv) the northbound entry slip road at Junction 3

"the works period" means a period of:

- (i) 10 hours starting at 20:00 hours on Monday 8th July 2013 or any subsequent Monday, Tuesday, Wednesday, Thursday, Friday or Sunday night thereafter until the said works have been completed; and
- (ii) 15 hours starting at 19:00 hours on Saturday 13th July 2013 or any subsequent Saturday until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the first length of carriageway, the second length of carriageway, the third length of carriageway or a slip road.
- **4.** The provisions of article 3 of the Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
