## **ROAD TRAFFIC**

## The M1 Motorway (Junction 37) (Temporary Restriction and Prohibition of Traffic) (No.3) Order 2013

Made--25th July 2013Coming into force-4th August 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M1 Motorway and connecting roads, in the District of Barnsley, in the County of South Yorkshire, is satisfied that traffic on that motorway and one of those connecting roads should be restricted and prohibited because carriageway resurfacing and repair works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b), makes the following Order: -

**1.** This Order may be cited as the M1 Motorway (Junction 37) (Temporary Restriction and Prohibition of Traffic) (No.3) Order 2013 and shall come into force on 4th August 2013.

2. In this Order; –

"the M1" means the M1 Motorway;

"the first length of northbound carriageway" means the M1 northbound carriageway between the noses of the northbound exit and entry slip roads at Junction 37(Dodworth), a distance of 1500 metres

"the second length of northbound carriageway" means the M1 northbound carriageway from a point 1000 metres south of the centreline of Keresforth Hill Road overbridge northwards for a distance of 1400 metres;

"the slip road" means the M1 northbound exit slip road at Junction 37;

"the works period" means the period of 10 hours starting at 20:00 hours on Monday 5th August 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 4 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the first length of northbound carriageway or the slip road.

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.

**5.** The provisions of regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulations  $1982(\mathbf{a})$  are suspended in relation to the hard shoulder adjacent to the second length of northbound carriageway as described in article 2 at such times and to such extent as may, from time to time, be indicated by traffic signs; and in this article "hard shoulder" has the meaning given in regulation 3(1)(e) of those Regulations.
