ROAD TRAFFIC

The A52 Trunk Road (Gamston, Nottinghamshire) (Temporary Prohibition of Traffic) Order 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A52 Trunk Road ("the A52"), is satisfied that traffic on lengths of that road near Gamston in the County of Nottinghamshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A52 Trunk Road (Gamston, Nottinghamshire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 8th July 2013.

2. In this Order:

"Gamston Roundabout" means the circulatory carriageway at the roundabout junction of the A52 and the A6011 at Gamston: "the trunk road" means -(a) the eastbound carriageway of the A52 from its junction with Ambleside to a point 515 metres east of Gamston Roundabout: (b) the westbound carriageway of the A52 from its junction with Stragglethorpe Road to its junction with Tollerton Lane: "layby" means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that

	on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;
"the central reservation"	means that part of the trunk road which separates its eastbound and westbound carriageways for the safety and guidance of vehicular traffic using those roads;
"the works period"	means the period starting at 00:01 hours on Saturday 13th July 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed in Gamston Roundabout or the trunk road.

4. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed through any gap in the central reservation of the trunk road.

5. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby situated adjacent to the westbound carriageway of the A52 approximately 1300 metres west of its junction with Stragglethorpe Road.

6. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or leave any side road at its junction with the trunk road.

7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

8. The provisions of –

a) articles 3, 4, 5 and 6 shall not apply to any vehicle –

i) being used for police, fire brigade or ambulance purposes;

- ii) proceeding at the direction of, or with the permission of, a police constable; or
- iii) being used in connection with the said works.

b) article 3 shall not apply to any vehicle proceeding in the trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
