ROAD TRAFFIC

The A27 Trunk Road (Milton Street – Gainsborough Lane) (Temporary Prohibition of Traffic) Order 2013

Made -	-	-	-	28th January 2013
Coming into force			-	16th February 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A27 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on a length of that road and on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order:-

1. This Order may be cited as the A27 Trunk Road (Milton Street – Gainsborough Lane) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 16th February 2013.

2. In this Order:

"the trunk road" means the A27 Trunk Road near Eastbourne in the County of East Sussex;

"the length of carriageway" means both carriageways of the trunk road between its junction with Milton Street west of Wilmington Green and its junction with Gainsborough Lane northwest of Eastbourne;

"a side road" means

- (i) The Street at its junction with the westbound carriageway of the trunk road,
- (ii) Thornwell Road at its junction with the eastbound carriageway of the trunk, or
- (iii) Folkington Road at its junction with the westbound carriageway of the trunk road;

"bus stop area" means an area of carriageway on the side of the trunk road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**);

"an A27 bus stop area" means any bus stop area in the length of carriageway;

"works" means resurfacing, high friction surfacing installation and signage works on the trunk road; and

"a works period" means a period of 9 hours starting at 2100 hours on Monday 18th February 2013 or on any subsequent day until 15th August 2014.

3. Subject as mentioned in article 4 below, no person shall, during a works period –

(a) cause or permit any vehicle to enter or proceed in, or wait on, an A27 bus stop area; or

(b) cause or permit any vehicle to enter or proceed in a length of carriageway or a side road.

4. The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (d) any vehicle being used for winter maintenance purposes; or
- (e) a vehicle proceeding in the length of carriageway to or from premises accessible from, and only from, that road, to such extent as shall be indicated by traffic signs.
