ROAD TRAFFIC

The M25 Motorway (Junctions 9 - 10) (Temporary Prohibition of Traffic) Order 2013

Made - - - 27th August 2013

Coming into force - - 14th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 Motorway and connecting roads, is satisfied that traffic should be restricted and prohibited on lengths of that motorway and prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M25 Motorway (Junctions 9 - 10) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 14th September 2013.

2. In this Order:

"the motorway" means the M25 Motorway in the County of Surrey;

"the first length of motorway" means the clockwise carriageway of the motorway between Junction 9 (A243) and Junction 10 (A3 Portsmouth Road);

"the second length of motorway" means the anti-clockwise carriageway of the motorway between Junction 10 (A3 Portsmouth Road) and Junction 9 (A243);

- "a slip road" means –
- (i) the road leading to the clockwise motorway at Junction 9 (A243), or
- (ii) the road leading to the anti-clockwise motorway at Junction 10 (A3 Portsmouth Road);
- "works" means bridge structural repairs and all associated carriageway work;
- "a works period" means a period of
 - (i) 7 hours starting at 2200 hours on Monday 16th September 2013 or on any subsequent day other than a Friday, Saturday or Sunday,
 - (ii) 7 hours starting at 2300 hours on Friday 20th September 2013 or on any subsequent Friday,

until 13th March 2015.

- **3.** Subject as mentioned in articles 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the first length of motorway, the second length of motorway or a slip road.
- **4.** The provisions of articles 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (d) any vehicle being used for winter maintenance purposes; or
- (e) a vehicle proceeding in the first length of motorway, the second length of motorway or a slip road to or from premises accessible from, and only from, that motorway or that slip road, to such extent as shall be indicated by traffic signs.
