### ROAD TRAFFIC

# The A49 Trunk Road (A438 Roundabout Junction, Hereford) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 30th August 2013

Coming into force - - 6th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A49 Trunk Road ("the A49"), is satisfied that traffic on lengths of that road in the City of Hereford should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A49 Trunk Road (A438 Roundabout Junction, Hereford) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 6th September 2013.

#### 2. In this Order:

"Newmarket Street Roundabout" means the circulatory carriageway of the roundabout junction of the A49 with the A438 Newmarket Street;

"the trunk road" means the northbound and southbound carriageways of the A49 Edgar Street between Newmarket Street Roundabout and its roundabout junction with Newtown Road and Farriers Way;

"the works period" means the period starting at 05:00 hours on Sunday 8th September 2013 and ending when the said works have

been completed;

**3.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or Newmarket Street Roundabout, excluding the nearside lane of that roundabout leading from the westbound carriageway of the A438 Newmarket Street to the southbound carriageway of the A49 Victoria Street.

- **4.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to turn right from the southbound carriageway of the A49 Victoria Street into Eign Street.
- **5.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to turn left into the northbound carriageway of the A49 Victoria Street from
  - (a) Portland Street; or
  - (b) Eign Street
- **6.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to proceed in the northbound carriageway of the A49 Victoria Street between its junction with Eign Street and Newmarket Street Roundabout in any direction other than southwards.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- **8.** The provisions of
  - (a) articles 3 and 4 shall not apply to any vehicle
    - (i) being used for police, fire brigade or ambulance purposes; or
    - (ii) proceeding at the direction of, or with the permission of, a police constable; and
  - (b) article 3 shall not apply to any vehicle
    - (i) being used in connection with the said works; or
    - (ii) proceeding to and from premises which are accessible from, and only from, the trunk road.
