## **ROAD TRAFFIC**

The A1(M) Motorway (Junction 63 to Junction 65) and the A194(M) Motorway (Havannah to Birtley) (Temporary Restriction and Prohibition of Traffic) Order 2013

Made - - - - 5th September 2013

Coming into force - - 17th September 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway, the A194(M) Motorway, and connecting roads, in the County of Durham and the Districts of Gateshead and Sunderland, is satisfied that traffic on those motorways and some of those connecting roads should be restricted and prohibited because carriageway resurfacing and patching works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and regulations 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b), makes the following Order: -

**1.** This Order may be cited as the A1(M) Motorway (Junction 63 to Junction 65) and the A194(M) Motorway (Havannah to Birtley) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 17th September 2013.

## 2. In this Order: -

"the A1(M)" means the A1(M) Motorway;

"the A194(M)" means the A194(M) Motorway;

"the northbound carriageway" means the A1(M) northbound carriageway from the nose of the northbound exit slip road at Junction 63 (Blind Lane) northwards for a distance of 2990 metres;

"the first length of southbound carriageway" means the A1(M) southbound carriageway from the merge of the A194(M) with the A1(M) at Junction 65 (Birtley) southwards for a distance of 4270 metres;

"the second length of southbound carriageway" means the A1(M) southbound carriageway from the nose of the diverge of the A1(M) with the A1231 at Junction 65 to the nose of the southbound entry slip road at Junction 63, a distance of 4905 metres;

"the third length of southbound carriageway" is the A194(M) southbound carriageway from the nose of the southbound exit slip road at the A182 Havannah Interchange to its merge with the A1(M) at Junction 65;

"the first slip road" means the A1(M) southbound exit slip road at Junction 63,

"a second slip roads" means the:

- (i) A1(M) northbound entry and exit and southbound entry slip roads at Junction 64 (Vigo), or
- (ii) A194(M) southbound entry slip road at Havannah Interchange;

"the works period" means a period of 10 hours starting at 20:00 hours on Wednesday 18th September 2013 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the northbound carriageway and the first length of southbound carriageway.
- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of southbound carriageway, the third length of southbound carriageway, the first slip road or the second slip roads.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
  - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purpose specified in paragraph (a) of this article.

- **6.** No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**a**) when used in accordance with regulation 3(5) of those Regulations.
- **7.** The provisions of regulation 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulations 1982 are suspended in relation to the hardshoulders adjacent to the second length of southbound carriageway or the first slip road as described in article 2 at such times and to such extent as may be indicated by traffic signs; and in this article, "hard shoulder" has the meaning given in regulation 3(1)(e) of those Regulations.
