ROAD TRAFFIC

The A1033 Trunk Road (Southcoates Roundabout to Marfleet Roundabout) (Temporary Prohibition of Traffic and Pedestrians)
Order 2013

Made - - - - 5th September 2013

Coming into force - - 15th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A1033 Trunk Road, in the East Riding of Yorkshire, is satisfied that traffic on that trunk road should be prohibited because carriageway and roundabout realignment and signalisation works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:-

1. This Order may be cited as the A1033 Trunk Road (Southcoates Roundabout to Marfleet Roundabout) (Temporary Prohibition of Traffic and Pedestrians) Order 2013 and shall come into force on 15th September 2013.

2. In this Order: -

"the A1033" means the A1033 Trunk Road eastbound and westbound carriageways between the junctions of Southcoates Roundabout and Marfleet Roundabout, and including the circulatory carriageway of the Northern Gateway Roundabout, a distance of approximately 1400 metres;

"the roundabout" means the circulatory carriageway and the footway of the of the A1033 Northern Gateway Roundabout;

"the footway" means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only;

"the works period" means a period of:

- (i) 10 hours commencing at 20:00 hours on Monday 16th September 2013 or any subsequent night thereafter until the said works have been completed; or
- (ii) 58 hours starting at 20:00 hours on Friday 27 September 2013 or any subsequent Friday night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 3, no person shall, during the works period,
 - (a) cause or permit any vehicle to enter or proceed in the A1033; or

- (b) enter or proceed in the roundabout.
- **4.** The provisions of article 2 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for or in connection with the said works, or for traffic officer or winter maintenance purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

nothing in article 3 shall apply to any vehicle proceeding in the A1033 to or from premises and property which is accessible for that vehicle from, and only from, that road;

and nothing in article 3 shall apply to any person engaged or assisting in the said works, or anything done at the direction of, or with the permission of, a police constable in uniform.
