ROAD TRAFFIC

The A27 Trunk Road (Clapham Interchange – Offington Corner and Grove Lodge Roundabout – Lancing Roundabout) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 9th September 2013

Coming into force - - 28th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A27 Trunk Road, is satisfied that traffic should be prohibited on lengths of the A27 because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A27 Trunk Road (Clapham Interchange – Offington Corner and Grove Lodge Roundabout – Lancing Roundabout) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 28th September 2013.

2. In this Order:

"the trunk road" means the A27 Trunk Road between Worthing and Lancing in the County of West Sussex:

"central reservation" means that part of the trunk road which separates its carriageways for the safety and guidance of vehicle traffic using that road;

"Salvington Hill (Swandean Hospital)" and "Swandean Close" mean, respectively, the roads known as Salvington Hill (Swandean Hospital) and Swandean Close at their junction with the eastbound carriageway of the trunk road east of Clapham Interchange (A280);

"Links Road" and "Hillside Avenue" mean, respectively, the roads known as Links Road and Hillside Avenue at their junction with the eastbound carriageway of the trunk road near Offington Corner (A24/A2031);

"Lyons Way" means the road known as Lyons Way at its junction with the eastbound carriageway of the trunk road east of Grove Lodge roundabout (A24);

"Halewick Lane" means the road known as Halewick Lane at its junction with the eastbound carriageway of the trunk road west of Lancing roundabout (A2025 – Grinstead Lane);

"Upper Brighton Road", "Church Lane", "Dankton Lane" and "Busticle Lane", mean, respectively, the roads known as Upper Brighton Road, Church Lane, Dankton Lane and Busticle Lane at their junction with the westbound carriageway of the trunk road west of Lancing roundabout (A2025 – Grinstead Lane);

"Upper Boundstone Lane", "Grand Avenue", "First Avenue" and "Eighth Avenue" mean, respectively, the roads known as Upper Boundstone Lane, Grand Avenue, First Avenue and Eighth Avenue at their junction with the westbound carriageway of the trunk road near Lancing roundabout (A2025 – Grinstead Lane);

"works" mean carriageway resurfacing, road marking, traffic detector loop, repair defective drainage pipes, install new gullies, recycle filter drains, replace defective lighting column and essential carriageway work on the trunk road;

"a first works period" means a period of 10 hours starting at 2000 hours on Monday 30th September 2013 or any subsequent day until 27th March 2015; and

"a second works period" means a period of 10 hours starting at 0800 hours on Monday 30th September 2013 or on any subsequent day until 27th March 2015.

- **3.** Subject as mentioned in article 6 below, no person shall, during a first works period, cause or permit any vehicle to enter or proceed in the gap in the central reservation of the trunk road opposite its junction with Holt Lane, opposite its junction with the track road signed "Holt Farm House" and opposite its junction with Cote Street east of Clapham Interchange (A280).
- **4.** Subject as mentioned in article 6 below, no person shall, during a second works period, cause or permit any vehicle -
 - (a) to turn right from the westbound carriageway of the trunk road into Salvington Hill (Swandean Hospital) and Swandean Close east of Clapham Interchange (A280); or
 - (b) to turn right from the westbound carriageway of the trunk road into Links Road and Hillside Avenue near Offington Corner (A24/A2031).
- **5.** Subject as mentioned in article 6 below, no person shall, during a first works period, cause or permit any vehicle
 - (a) to turn right from Lyons Way into the westbound carriageway of the trunk road east of Grove Lodge roundabout (A24);
 - (b) to turn right from Halewick Lane into the westbound carriageway of the trunk road west of Lancing roundabout (A2025 Grinstead Lane);
 - (c) to turn left from Upper Brighton Road into the westbound carriageway of the trunk road east of Grove Lodge roundabout (A24);
 - (d) to turn left from the southern side of its junction with Church Lane into the westbound carriageway of the trunk road west of Lancing roundabout (A2025 Grinstead Lane);
 - (e) to turn left from Dankton Lane and Busticle Lane into the westbound carriageway of the trunk road west of Lancing roundbout (A2025 Grinstead Lane); or
 - (f) to turn left from Upper Boundstone Lane, Grand Avenue, First Avenue and Eighth Avenue into the westbound carriageway of the trunk road near Lancing roundabout (A2025 Grinstead Lane).
- **6.** The provisions of articles 3, 4 and 5 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
