ROAD TRAFFIC

The A14 Trunk Road (Harrington to Kettering, Northamptonshire) (Temporary Restriction and Prohibition of Traffic) Order 2013

Made - - - - 30th August 2013

Coming into force - - 6th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A14 Trunk Road ("the A14") and connecting roads, is satisfied that traffic on lengths of that trunk road and two of those connecting roads between Harrington and Kettering in the County of Northamptonshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A14 Trunk Road (Harrington to Kettering, Northamptonshire) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 6th September 2013.

2. In this Order -

"the first length of trunk road" means eastbound carriageway of the A14 from a point 3220 metres west of the exit slip road leading to the roundabout junction with the A6 and the B576 Harrington

Road at Rothwell to that junction;

"the second length of trunk road" means the eastbound carriageway of the A14 from its

junction with the exit slip road leading to the A6 and B576 Harrington Road at Rothwell to its junction with the entry slip road leading from the roundabout junction with

the A43 and A4300 at Kettering;

"a slip road" means the slip road leading –

- i) to the eastbound carriageway of the A14 from the B576 Kettering Road at Rothwell; and
- ii) to the eastbound carriageway of the A14 from the

roundabout junction of the A6 and B576 Harrington Road at Rothwell;

"the works period"

means the period starting at 21:00 hours on Friday 11th September 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the second length of trunk road or a slip road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of –
 - a) article 3 shall not apply to any vehicle being used for special forces purposes;
 - b) articles 3 and 4 shall not apply to any vehicle -
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable; and
 - c) article 4 shall not apply to any vehicle being used in connection with the said works.
