ROAD TRAFFIC

The A14 Trunk Road (Junction 20 Ellington, Cambridgeshire) Eastbound (Temporary Prohibition of Traffic) Order 2013

Made - - - 23rd September 2013

Coming into force - - 30th September 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A14 Trunk Road ("the A14") and connecting roads, is satisfied that traffic on lengths of that road and on some of those connecting roads, in the County of Cambridgeshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A14 Trunk Road (Junction 20 Ellington, Cambridgeshire) Eastbound (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 30th September 2013.

2. In this Order –

"a slip road" means the exit slip road leading from and the entry slip road leading to the eastbound carriageway of the A14 at Junction 20 Ellington;

"lay-by" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means a way constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"works" mean ditch clearance, renewal of road markings and verge, barrier, bridge and drainage maintenance;

"a works period" means a period of -

- (a) 12 hours starting at 18.00 hours on Monday 7th October 2013 or on any subsequent day (other than a Thursday, a Friday or a Sunday),
- (b) 13 hours starting at 18.00 hours on Thursday 10th October 2013 or on any subsequent Thursday,
- (c) 15 hours starting at 19.00 hours on Friday 11th October 2013 or on any subsequent Friday, or

(d) 11 hours starting at 19.00 hours on Sunday 13th October 2013 or on any subsequent Sunday,

until the works have been completed;

"the works period" means the period starting at 09.00 hours on Monday 7th October 2013 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in article 4 no person shall cause or permit any vehicle to enter -
 - (a) or proceed in a slip road, during a works period,
 - (b) or proceed in any lay-by adjacent to the eastbound carriageway of the A14 situated between points 1200 metres east and 850 metres west of the centre point of the overbridge at Junction 20 Ellington Interchange, during the works period, or
 - (c) or leave the eastbound carriageway of the A14 at its junction with the access road situated opposite the entrance to Huntingdon District Council Recycling Depot.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to any vehicle
 - (a) being used in connection with the works or for traffic officer purposes,
 - (b) being used for police, fire and rescue authority or ambulance purposes,
 - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform, or
 - (d) requiring access to or from properties which are accessible from, and only from, the A14.
