## ROAD TRAFFIC

## The A45 Trunk Road (South of Coventry) (Temporary Prohibition of Traffic in Laybys) Order 2013

Made - - - - 8th November 2013

Coming into force - - 15th November 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45"), is satisfied that traffic on a length of that road, south of the City of Coventry, should be prohibited because works are proposed to be executed nearby:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A45 Trunk Road (South of Coventry) (Temporary Prohibition of Traffic in Laybys) Order 2013 and shall come into force on 15th November 2013.

## 2. In this Order –

"Toll Bar Roundabout" means the circulatory carriageway of the A45/A46/B4110/Rowley Road roundabout junction;

"Stivichall Roundabout" means the circulatory carriageway of the

A45/A46/A444 roundabout junction;

"layby" means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the

type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(**b**) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period"

means the period starting at 00:01 hours on Tuesday 19th November 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby situated adjacent to the eastbound carriageway or westbound carriageway of the A45 between Tollbar Roundabout and Stivichall Roundabout.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used for police, fire brigade or ambulance purposes or vehicles being used in connection with the said works.
