ROAD TRAFFIC

The A38 and A516 Trunk Roads (Mickleover, Derby) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 8th November 2013

Coming into force - - 15th November 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), the A516 Trunk Road ("the A516") and connecting roads, is satisfied that traffic on lengths of those trunk roads and some of those connecting roads, near Mickleover in the city of Derby and the County of Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A38 and A516 Trunk Roads (Mickleover, Derby) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 15th November 2013.

2. In this Order:

"Micklemeadow Roundabout" means the circulatory carriageway of the A38/Staker

Lane/ Dales Lane/ Rykneld Road roundabout junction,

south of Mickleover;

"Kingsway Roundabout" means the circulatory carriageway of A38/A5111

Kingsway roundabout junction, north east of Mickleover;

"the trunk road" means –

- a) the northbound carriageway of the A38 from its junction with the slip road leading to Micklemeadow Roundabout to its junction with Kingsway Roundabout;
- b) the southbound carriageway of the A38 from Kingsway Roundabout to its junction with the slip road leading from Micklemeadow Roundabout;

- c) the eastbound carriageway of the A516 from its junction with the slip road leading to the roundabout junction of Ladybank Road and Etwall Road to its junction with the northbound carriageway of the A38; and
- d) the westbound carriageway of the A516 from its roundabout junction with the B5020 Uttoxeter Road to its junction with the southbound carriageway of the A38;

"a slip road"

means the slip road leading -

- a) to the northbound carriageway of the A38 from Micklemeadow Roundabout; and
- b) to the southbound carriageway of the A38 from Kingsway Roundabout;

"the works period"

means the period starting at 20:00 hours on Monday 18th November 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** The provisions of articles 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
