### **ROAD TRAFFIC**

# The M42 Motorway (Junctions 4 to 5, Solihull) (Temporary Prohibition and Restriction of Traffic) Order 2013

Made - - - 18th November 2013

Coming into force - - 25th November 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the M42 Motorway ("the M42") and connecting roads, is satisfied that traffic on a length of that motorway and one of those connecting roads, in the Metropolitan Borough of Solihull, should be prohibited and restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b) hereby makes the following Order: -

**1.** This Order may be cited as the M42 Motorway (Junctions 4 to 5, Solihull) (Temporary Prohibition and Restriction of Traffic) Order 2013 and shall come into force on 25th November 2013.

#### 2. In this Order:

"the motorway" means the northbound carriageway of the M42 from its

junction with the exit slip road at Junction 4 to its junction

with the entry slip road at Junction 5;

"the slip road" means the slip road leading from the northbound

carriageway of the M42, at Junction 5;

"the Regulation" means the Motorways Traffic (England and Wales)

Regulations 1982;

"a hard shoulder" means the hard shoulder, within the meaning of

Regulation 3(1)(e) of the Regulations, which is adjacent to

the motorway;

"the works period"

means the period starting at 21:00 hours on Thursday 28th November 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on the motorway.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the slip road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- **6.** The provisions of
  - (a) articles 3 and 4 shall not apply to any vehicle
    - (i) being used for police, fire brigade or ambulance purposes; or
    - (ii) proceeding at the direction of, or with the permission of, a police constable;
  - (b) article 3 shall not apply to any vehicle being used for special forces purposes; and
  - (c) article 4 shall not apply to any vehicle being used in connection with the said works or by, or with the permission of traffic officer in uniform.
- 7. During the works period, regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Regulations are hereby suspended in respect of a hard shoulder, at such times and to such extent as may from time to time be indicated by traffic signs.
