## ROAD TRAFFIC

The A45 and A46 Trunk Roads (South East of Coventry) (Temporary Restriction and Prohibition of Traffic) Order 2013

Made - - - - 3rd December 2013

Coming into force - - 10th December 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45") and the A46 Trunk Road ("the A46"), is satisfied that traffic on lengths of those roads, in the City of Coventry and in the County of Warwickshire, should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by sections 14(1)(a) and 15(2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A45 and A46 Trunk Roads (South East of Coventry) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 10th December 2013.

## 2. In this Order:

"Tollbar End Roundabout" means the circulatory carriageway of the A45/A46/B4110

roundabout junction at Tollbar End;

"Festival Roundabout" means the circulatory carriageway of the A45/A46/A444

roundabout junction near Stivichall;

"TGI Roundabout" means the circulatory carriageway of the A46/A428

roundabout junction near Binley Woods;

"Fruit Farm Underbridge" means the bridge carrying the A46 over the access road

leading to the fruit farm 575 metres north east of Tollbar

End Roundabout:

"the first length of trunk road" means –

i) the eastbound carriageway of the A46 from Tollbar End Roundabout to a point 484 metres

north east of the centreline of Fruit Farm Underbridge;

- ii) the westbound carriageway of the A46 from a point 780 metres north east of the centreline of Fruit Farm Underbridge to Tollbar End Roundabout;
- iii) the eastbound and westbound carriageways of the A45 from a point 870 metres west of the centrepoint of Festival Roundabout to Tollbar End Roundabout;
- iv) the westbound carriageway of the A45 from Tollbar End Roundabout to a point 60 metres west of the centrepoint of Festival Roundabout;
- v) the westbound carriageway of the A45 from a point 66 metres south east of Brandon Lane to Tollbar End Roundabout; and
- vi) the eastbound carriageway of the A45 from Tollbar End Roundabout to a point 66 metres south east of Brandon Lane;

"the second length of trunk road"

means the westbound carriageway of the A46 from a point 1580 metres north east of, to a point 780 metres north east of, the centreline of Fruit Farm Underbridge;

"the third length of trunk road"

means -

- the eastbound and westbound carriageways of the A45 between Festival Roundabout and Tollbar End Roundabout; and
- ii) the northbound and southbound carriageways of the A46 between Tollbar End Roundabout and TGI Roundabout;

"a slip road"

means the slip road leading -

- i) from Tollbar End Roundabout to the roundabout junction with Siskin Drive and Rowley Road; and
- ii) to Tollbar End Roundabout from the roundabout junction with Siskin Drive and Rowley Road;

"the works period"

means the period starting at 00.01 hours on Wednesday 11th December 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the first length of trunk road or a slip road.
- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the second length of trunk road.
- **5.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the third length of trunk road.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 7. The provisions of
    - (a) articles 3, 4 and 5 shall not apply to any vehicle
      - (i) being used for police, fire brigade or ambulance purposes; or
      - (ii) proceeding at the direction of, or with the permission of, a police constable;
    - (b) articles 3 and 4 shall not apply to any vehicle being used for special forces purposes; and
    - (c) article 5 shall not apply to any vehicle
      - (i) being used in connection with the said works; or
      - (ii) proceeding in the third length of trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
- **8.** The Secretary of State is satisfied that the execution of the said works will take longer than a period of eighteen months starting on the date when this Order comes into force.
- **9.** The A45 and A46 Trunk Roads (South East of Coventry) (Temporary Restriction of Traffic) Order 2013(a) is hereby revoked.
