- **2.** The Sheffield City Council (Bus Rapid Transit Northern Route—Tinsley Link—Fitzwilliam Bridge) Scheme 2012 Confirmation Instrument 2013 ("the Scheme") is hereby confirmed.

SCHEDULE

THE SHEFFIELD CITY COUNCIL (BUS RAPID TRANSIT NORTHERN ROUTE—TINSLEY LINK—FITZWILLIAM BRIDGE) SCHEME 2012

Sheffield City Council (hereinafter referred to as "the Council") make this Scheme in exercise of their powers under Section 106(3) of the Highways Act 1980 and of all other powers enabling them in that behalf—

- 1. The Council are authorised to construct over the navigable waters of the River Don the bridge specified in the Schedule to this Scheme as part of the highway which they are proposing to construct and improve between the Halfpenny footbridge, O.S. map reference 4004 9154 and the River Don, O.S. map reference 4013 9150 in Tinsley, Sheffield, in the County of South Yorkshire.
- **2.** This Scheme may be cited as "The Sheffield City Council (Bus Rapid Transit Northern Route —Tinsley Link—Fitzwilliam Bridge) Scheme 2012".

EXPLANATORY NOTE

(This note is not part of the Order)

This instrument confirms a scheme to construct over the navigable waters of the River Don a bridge as part of the highway which is to be constructed/improved between the Halfpenny footbridge, O.S. map reference 4004 9154 and the River Don, O.S. map reference 4013 9150 in Tinsley, Sheffield, in the County of South Yorkshire.
