# The Air Navigation (Restriction of Flying) (Duxford Aerodrome) (Amendment) Regulations 2013

 Made
 25th March 2013

 Coming into force
 26th May 2013

The Secretary of State deems it necessary in the public interest to restrict flying in the vicinity of Duxford, Cambridgeshire by reason of the holding of flying displays that are scheduled to take place at the aerodrome there on 26th May, 13th and 14th July, 7th and 8th September and 13th October 2013.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Duxford Aerodrome) (Amendment) Regulations 2013 and come into force on 26th May 2013.

### **Amendment of Regulations**

- **2.**—(1) The Air Navigation (Restriction of Flying) (Duxford Aerodrome) Regulations 2013(**b**) are amended as follows.
  - (2) For regulation 3(1) substitute the following—
    - "3.—(1) Subject to paragraph (2) between—
      - (a) 0930 hours and 1700 hours on 26th May 2013, and
      - (b) 1200 hours and 1700 hours on—
        - (i) 13th and 14th July 2013,
        - (ii) 7th and 8th September 2013, and
        - (iii) 13th October 2013,

no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by a circle having a radius of 2.2 nautical miles whose centre is at 520539N 0000753E.".

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations amend the Air Navigation (Restriction of Flying) (Duxford Aerodrome) Regulations 2013 (S.I. 2013/89) ("the principal Regulations"). The amendment brings forward from 1200 hours to 0930 hours the commencement of the flying restrictions applicable under the principal Regulations in relation to the first day of flying displays at Duxford Aerodrome, namely on 26th May 2013. The restrictions applicable to the remaining days in 2013 are unaltered.

Full details of the restricted airspace will be promulgated by Aeronautical Information Circular and NOTAM.
