ROAD TRAFFIC

The A483 Trunk Road (Shropshire) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 18th February 2013

Coming into force - - 25th February 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A483 Trunk Road ("the A483"), is satisfied that traffic on a length of that road, in the County of Shropshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A483 Trunk Road (Shropshire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 25th February 2013.

2. In this Order:

"the trunk road" means the northbound and southbound carriageways of

the A483 from its roundabout junction with the A5 and B4579 (Mile End Roundabout) to a point 40 metres south of the centreline of its junction with the unnamed road leading to Pen Y Foel north of Llanymynech (Welsh

border);

"the works period" means the period starting at 00.01 hours on Monday 4th

March 2013 and ending when the said works have been

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or leave the trunk road at its junction with
 - (a) the unnamed road leading to Hazel Grove 452 metres south of its junction with the B5069;
 - (b) Albridge Lane;

- (c) Church Lane;
- (d) the B4396;
- (e) the A495;
- (f) Penygarreg Lane;
- (g) Station Road (north);
- (h) Station Road (south);
- (i) Briggs Lane;
- (j) Stargarreg Lane; and
- (k) Rhew Level Lane.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of articles 3 and 4 shall not apply to any vehicle
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works;
