ROAD TRAFFIC

The A47 Trunk Road (Soke Parkway, Junction 17 Bretton Way to Junction 18 Lincoln Road, Peterborough) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 25th February 2013

Coming into force - - 4th March 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A47 Trunk Road ("the A47"), is satisfied that traffic on lengths of that road in the City of Peterborough should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the A47 Trunk Road (Soke Parkway, Junction 17 Bretton Way to Junction 18 Lincoln Road, Peterborough) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 4th March 2013.

2. In this Order -

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

"the trunk road" means the A47 Soke Parkway –

- (a) westbound carriageway between the tips of the nosings of the exit slip road at Junction 18 A15/Lincoln Road Interchange and the entry slip road at Junction 17 Bretton Way Interchange, and
- (b) eastbound carriageway between the tips of the nosings of the exit slip road at Junction 17 Bretton Way Interchange and the entry slip road at Junction 18 A15/Lincoln Road Interchange;

"works" mean safety barrier replacement on Lincoln Road Bridge;

"a works period" means a period of 9 hours starting at 21.00 hours on Monday 11th March 2013 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the trunk road.

- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle
 - (a) being used for or in connection with the works or for winter maintenance,
 - (b) being used for, police, fire and rescue authority ambulance or traffic officer purposes, or
 - (c) proceeding at the direction, or with the permission, of a police constable, or a traffic officer in uniform.
