ROAD TRAFFIC

The A36 Trunk Road (Deptford Junction to Wilton, Salisbury) (Temporary Restriction and Prohibition of Traffic) Order 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A36 Trunk Road ("the A36") and connecting roads, is satisfied that traffic on lengths of that road and one of those connecting roads between the Deptford Junction and Wilton, Salisbury, in Wiltshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order:-

1. This Order may be cited as the A36 Trunk Road (Deptford Junction to Wilton, Salisbury) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 2nd March 2013.

2. In this Order –

"the first length of the A36" means the A36 from the centre of its junction with the A303 at Deptford to the western edge of Wilton Roundabout, Salisbury;

"the second length of the A36" means the A36 from a point at the centre of its junction with the A303 at Deptford to a point at the centre of its junction with Over Street at Stapleford;

"the third length of the A36" means the A36 from the south eastern edge of Wilton Roundabout to a point 500 metres southeast of that roundabout edge;

"the slip road" means the A303 westbound exit slip road to the A36 at the Deptford Junction;

"the works" mean resurfacing and road marking works;

"a works period" means a period of 10 hours starting at 20.00 hours on Monday 4th March 2013 or on any subsequent night and ending when the said works have been completed;

"the works period" means the period starting at 20.00 hours on Monday 4th March 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the first length of the A36.

4. Subject as mentioned in articles 7 and 9, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the second length of the A36.

5. Subject as mentioned in articles 7 and 9, no person shall, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the second length of the A36 whilst traffic signs of a character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on that road are displayed.

6. Subject as mentioned in articles 7 and 8, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the third length of the A36 or the slip road.

7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) anything done at the direction or with the permission of a constable.

8. The provisions of articles 3 and 6 shall not apply to:

- (a) a vehicle being used in connection with the said works or for traffic officer purposes;
- (b) vehicles proceeding to or from premises that are accessible from and only from the A36.

9. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
