The Air Navigation (Restriction of Flying) (RNAS Yeovilton) Regulations 2014

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Yeovilton, Somerset by reason of the intended holding of flying displays that are scheduled to take place on 25th and 26th July 2014.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order $2009(\mathbf{a})$.

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (RNAS Yeovilton) Regulations 2014 and come into force on 25th July 2014.

Interpretation

2. In regulation 3 all times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1400 hours and 1700 hours on 25th July 2014 and between 1000 hours and 1600 hours on 26th July 2014 no aircraft is to fly below 6,000 feet above mean sea level within the area bounded by a circle having a radius of 6 nautical miles whose centre is at 510033N 0023820W.

(2) Paragraph (1) does not apply to any aircraft flying in accordance with a clearance issued by the air traffic control unit at RNAS Yeovilton.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace in the vicinity of RNAS Yeovilton, Somerset for flying displays and associated rehearsals that are scheduled to take place there on 25th and 26th July 2014. A large number of civil and military aircraft will be involved in highenergy manoeuvres during the display. The Civil Aviation Authority's Safety and Airspace Regulation Group (SARG) considers that flying should be restricted in the vicinity of the displays for reasons of public safety and this has been agreed with the Department for Transport.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time.

Full details of the restricted airspace will be published by Aeronautical Information Circular and NOTAM.
